#### MONTHLY BRINE ROAD-SPREADING REPORT

#### **GENERAL INFORMATION**

As required by §§ 78.70(a) and 78.70a(a), a Road-spreading of Brine Plan must be submitted to the Department of Environmental Protection (DEP) for its approval prior to implementation of any road-spreading of brine. This plan approval is granted on a calendar year basis. Plans approved for road-spreading of brine for dust control and road stabilization will expire on December 31<sup>st</sup> of each year. Plans approved for pre-wetting, anti-icing and de-icing will expire on June 30<sup>th</sup> of each year. Any revisions to the plan must be submitted to DEP for approval prior to implementation of any modifications. As required by §§ 78.70(l) and 78.70a(r), the responsible person identified on the road-spreading plan for dust control and road stabilization or pre-wetting, anti-icing and de-icing, shall submit a monthly report to DEP utilizing this form (5500-FM-OG0000 Rev.) listing the locations, frequency and amounts of brine spread or pre-wetted antiskid material spread during the previous month. The monthly brine report must be submitted by the 15<sup>th</sup> day following the month in which the brine was spread. The report must be submitted even if no road-spreading of brine took place during the month. Submit forms to the appropriate DEP Oil and Gas District Office listed on the next page:

#### INSTRUCTIONS

- 1. **Heading:** List name of company performing the brine spreading; county and municipality where spreading occurred; month and year of spreading; and Road-spreading Plan approval number, if available.
- 2. **Date:** List month and day of road-spreading activity.
- 3. **Road Number, Name, or Property Name:** List road number (e.g. T746), road name (e.g. Jones Road), or property name (e.g. Smith Property). The name or numbers should be the same as shown on maps submitted with the plan.
- 4. **Describe Segment of Road Spread:** Enter portion of road spread if less than the entire length. Examples: "started at T745, went 1.5 mi. north" or "Segment 0030-0080". Also, use any GPS coordinates if these coordinates are shown on the approved Road-spreading of Brine Plan.
- 5. **Length of Roadway Spread:** Report length of roadway spread to the nearest 0.1 mile or report square yards spread for lots.
- 6. **Brine Dosage Spread:** List number of gallons spread on road or property.
- 7. Width of Spreader Bar: Provide width of spreader bar in feet.
- 8. **Width of Roadway Spread:** List actual width (in feet) of roadway spread (width of spreader bar for a single pass or the actual width of roadway spread for side by side passes).
- 9. License Plate Number of Truck: Document license plate number of the truck that spread brine on roads as listed in the report.
- 10. **Totals:** Enter the total length of roadway and number of gallons spread. If no brine was spread in the township for the month, report "0".
